Whereas,

Since 2001, **Educatiooon 3000 / Pedagoogia 3000®** (henceforth referred to as P3000) represented by Association 3000, headquartered in La Paz, Bolivia, and approved by administrative departmental resolution #03252014 on April 16<sup>th</sup> 2014, and presided by Noemi Paymal, proposes to co-create an Education that is more open, pleasant, more humane and more cooperative in all corners of the world.

In 2008, **EME**, A World link for A New Education, with established residency in Arica, Chile, approved by the Ministry of Justice of Chile, registration # 144681 on August 19<sup>th</sup> 2013, represented by Lorena Riquelme Jaramillo, with the emAne International Foundation, invites all countries to come together and change Education at a global level. Its headquarters is located in Chile and is in contact with 53 countries to date (2015).

On January 19, 2015, P3000® and EME signed an agreement with the UNESCO Center Foundation for Human Rights Training, Global Citizenship and Culture of Peace concerning P3000 training and other activities.

And whereas,

All parties are in agreement,

- That at the dawn of a new millennium, the parties recognize the importance of creating partnerships, links and supportive networks to promote and co-create an Integral Education with Conscience for all human beings, that includes Peace Culture at all levels.
- That their mutual agreement on the need to create networks of interaction, collaboration and complementarity that acting on different scales, produce the necessary synergy effects to achieve the above mentioned objectives.
- That their conviction to act in a coordinated manner to harness the potential of each of the parties for the benefit of the children and young people of the world, thus preserving the autonomy and specific mission of each institution.

Therefore, with the purpose of establishing a framework of partnership, the parties subscribe to this Agreement pursuant to the following precepts:

1. The objective of the present Agreement is to promote mutual cooperation in the field of Integral Education and Peace Culture, within the guidelines of action of the parties.

2. Each signatory Institution of this Agreement of Institutional Alliance will develop their own activities, focusing on the goals set by each one of them. Likewise, they will establish mechanisms for cooperation and coordination of their actions, exchanging information about their respective activities, announcements and publications, and will offer a mutual participation in those activities that can promote converging objectives, to achieve a greater impact on the construction of an Integral Education with Conscience, as well as generate Peace Culture in all its forms and levels.

3. As of this Agreement, parties may include each other both in their institutional Web Sites as well as in any management or procedure they perform, if they consider it necessary, stating that they are working in partnership, thus supporting each other. In case of specific actions or projects, just an exchange of emails between previously designated parties by the institutions involved will be all that is necessary to carry out such actions.

4. The Agreement shall come into force at the time of its signature for a one-year duration, automatically renewable for an equal period. If one of the Parties decides to terminate the agreement, it shall communicate it in writing to the other institutions, with two months in advance.
